To encourage the emergence of a new generation of fulfilled professionals and committed citizens, who will play an active role in transforming their community into a fair, hopeful and sustainable society.

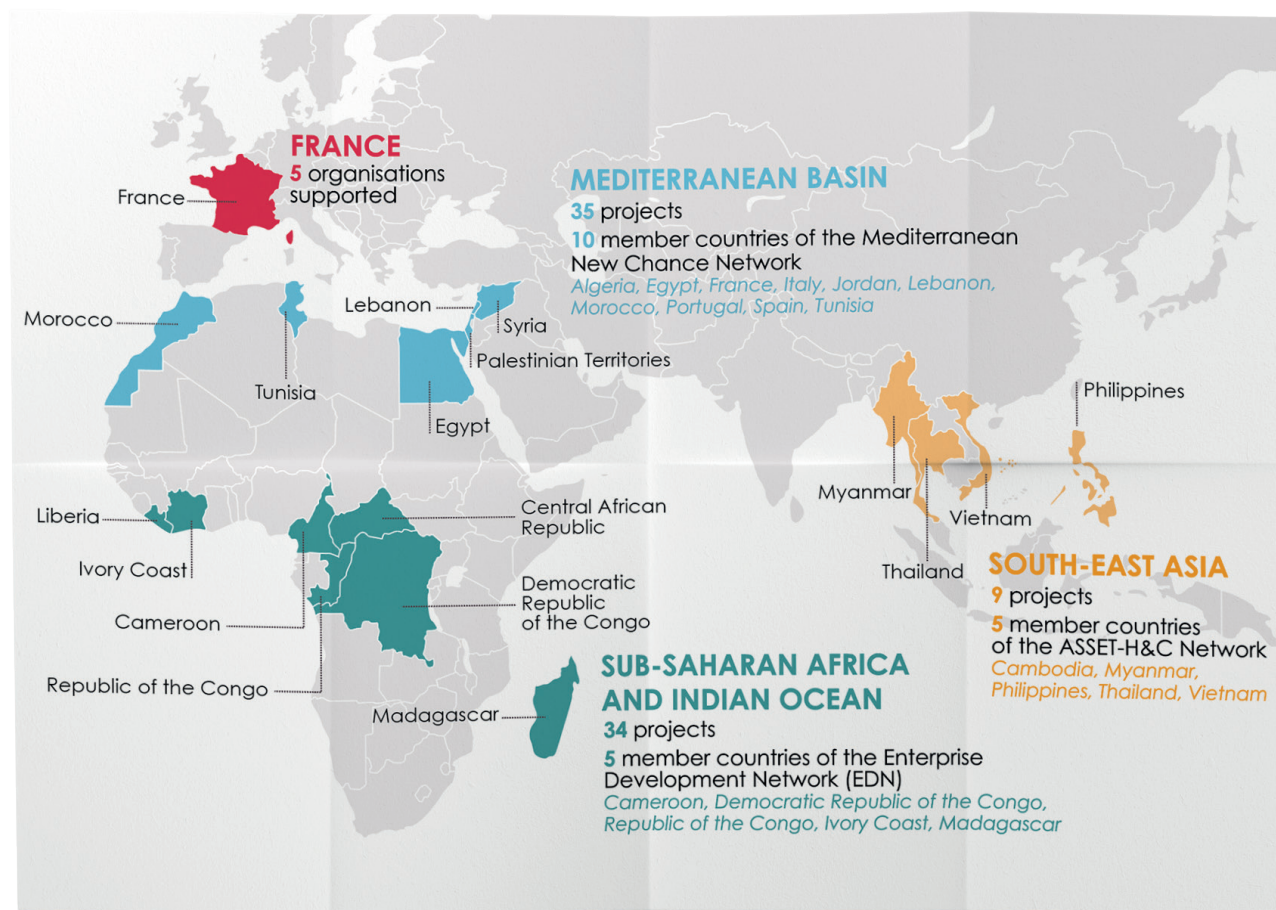

Supporting actors in the fields

The IECD supports nearly 200 public and private local organisations in the fields of education, vocational training and professional integration, and entrepreneurship support, acting as a catalyst for empowerment and helping them play an active role in their own development.

Modernising to align with market needs

The IECD supports its partners in creating or redesigning vocational training courses leading to diplomas or qualifications. To meet the needs of companies and the employment market, it also develops shorter training courses, focusing on the mastery of basic techniques, which are cross-disciplinary skills sought after by employers. In **Vietnam**, for example, the IECD supports the District 12 Technical Economic College in a programme combining technical training, cross-disciplinary skills and work experience.

Supervised by IECD-trained internship supervisors, students develop their ability to adapt in real-life situations and are fully prepared for the realities of the market.

Additionally, **21 new curricula have been created**, ranging from degree courses recognised by the relevant ministries to continuing education and qualifying courses that encourage rapid integration into the workplace.

Enhancing the capacities of frontline staff to secure long-term impact

The digital platform, CAMPUS IECD, offers **more than 40 training modules** designed to transform the practices of support professionals (trainers, company tutors, guidance and integration counsellors, educators, etc.). The courses cover active pedagogy, the skills-based approach, adopting an educational posture adapted to each stakeholder, gender equality, situational management and the use of digital technology in training activities.

This offer is complemented by close, individualised support through the Trainers' Operational Reinforcement Programme (PROF), which is made up of four components:

- 1) initial training modules,
- 2) individual coaching from pedagogical experts,
- 3) running communities of practice,
- 4) support for training centres in identifying and developing the skills of "PROF referents", who act as "trainers of trainers" for their peers.

Since 2022, **the PROF programme has benefited 600 trainers** across the different countries where the IECD operates.

Establishing itself sustainably in both the economic and academic ecosystems

The IECD supports its local partners in structuring and sustaining their activities, providing them with methodology, tools and training for middle managers (via CAMPUS IECD) and formalising their institutional and strategic projects with a view to development and expansion. Furthermore, the IECD helps them to become firmly rooted in their economic and academic ecosystem, by promoting synergies with their natural partners: companies, training providers and entrepreneurs, in the belief that the collective value of the network exceeds the sum of individual efforts.

- **Specialised teams providing cross-functional support** in areas such as monitoring and evaluation, communication, management of partner relations, human resources, compliance and financial monitoring.



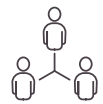

NETWORKS OF PROFESSIONAL STAKEHOLDERS

The IECD develops and leads 3 networks of professionals stakeholders to increase its impact and respond to regional

► In the Mediterranean basin, where the youth unemployment rate is close to 30% (World Bank), the **MEDITERRANEAN NEW CHANCE NETWORK (MedNC)** creates synergies between the shores of the Mediterranean, building bridges of cooperation, mobility and opportunities for young people in vulnerable situations and for training and integration professionals. Present in 10 countries through 18 member organisations, it strengthens the capacities of local players and disseminates innovative projects and practical solutions on a wider scale. More than 52,000 young people benefit indirectly from its actions.

► In South-East Asia, where tourism accounts for 12% of the region's gross domestic product and generates 11% of jobs (World Tourism Organisation), the **ASSOCIATION OF SOUTHEAST ASIAN SOCIAL ENTERPRISES FOR TRAINING IN HOSPITALITY & CATERING (ASSET-H&C)** brings together vocational training centres whose mission is to train young people from vulnerable communities in the hotel, restaurant and tourism industries. The network's member schools offer practical training within their facilities, enabling them to move on to high-quality jobs in the hotel and tourism sectors.

THE ENTREPRISE DEVELOPMENT NETWORK (EDN) in sub-Saharan Africa brings together the IECD and 5 partners implementing the micro and small enterprise support programme. It is dedicated to supporting and training entrepreneurs. The network's members work together to strengthen their local presence, improve training content, certify their network of trainers and boost the entrepreneurial fabric of the regions where they are based.

Informed guidance for a chosen future

How can you know what you want to become if you don't know yourself? How can you move forward without knowing which direction to take?

Around the world, nearly one in four young people drop out of school before completing their education (UNESCO). Nearly one in two will never work in the job they had considered: poverty, loss of meaning, inadequate training, or lack of support explain these broken paths.

At a pivotal moment in their lives, the IECD supports young people in their personal, academic, and professional development, enabling them to make informed choices, revealing their talents, and promoting equal opportunities.

Taking control of your life and building your future

The IECD implements measures to re-engage young dropouts, with approaches that vary according to the context: programmes facilitating access to vocational training in Tunisia and the Central African Republic, boarding schools for middle school students and a preparatory year for higher education in Madagascar.

Successful career guidance: the key to social and professional integration

Without career guidance, the most vulnerable young people often choose paths with no job prospects. The IECD helps them to get to know themselves better and discover their environment so that they can make free training choices. A guidance counselor helps them explore the professional world and refine their choices through immersive work experiences, introductions to vocational trades, and forums. At the Janah centre in Lebanon, they can envision paths to integration by freeing themselves from social and gender norms.

Raising awareness among families and education and youth professionals to better support young people

Through its "Parent Schools" in Lebanon and Madagascar, the IECD supports parents, who play a key role in their children's education, in helping them achieve their academic, social, and professional aspirations.

And professionals such as middle school teachers, guidance counselors, and youth workers at youth centres also benefit from initial and ongoing training.

Gateways to employment

250 million young people worldwide are neither in employment nor in education or training. In Africa, 30 million young people enter a labour market every year that struggles to offer them prospects.

However, companies are also struggling to recruit qualified staff. This paradox can largely be explained by the mismatch between the training on offer and market expectations. Courses are often disconnected from the realities of the workplace and include little practical experience. As a result, young people do not have the skills that employers need.

With this in mind, the IEC D is strengthening vocational training stakeholders and is building bridges between the world of business and vocational training, thereby improving young people's employability.

Strengthening vocational training stakeholders

With the 183 private and public training centres it supports, the IEC D is rolling out revamped curricula that promote comprehensive training, combining technical, academic, and human skills. Depending on the needs of these centres, the IEC D provides capacity building (training of trainers), modernises their technical facilities, and promotes better integration into the academic and economic ecosystem.

Targeting promising trades in key sectors

The IEC D guides young people in vulnerable situations or with low levels of education towards promising trades in sectors that create jobs:

- Hospitality and catering
- Health
- Agriculture
- Energy, transport, industry
- Construction

Through its projects, the IEC D is rolling out **new training courses leading to qualifications, certificates, or diplomas** that meet the needs of businesses. To broaden its impact, the IEC D cooperates with local institutions to obtain official recognition for its courses and contribute to the reform of vocational training systems. **The IEC D has produced 21 training standards, 11 of which have received state accreditation.**

Positioning businesses within vocational training: between work-study programmes and training workspaces

Putting businesses at the heart of training is key to creating the conditions for successful professional integration: the IECD is moving training programmes toward a work-study model, with a significant portion of the curriculum devoted to practical internships in companies. With the support of mentors, young people become familiar with the business world and develop their self-confidence and professional skills.

For example, in **Ivory Coast**, in collaboration with the Ministry of Technical Education, the IECD is rolling out work-study programmes in the "Industrial Maintenance" sector, which is strengthening the employability of **more than 400 young people** within a network of around 30 partner companies.

The approach sometimes goes even further, with the establishment of "school-based enterprises." In these structures, which are integrated into training centres, young people experience corporate life to the fullest: they market the goods and services they produce during their training.

In **South-East Asia** and **Madagascar**, the IECD's training hotels, restaurants, and bakeries provide real-life training to more than 500 young people. In **Morocco**, 140 young people are being trained in the installation and maintenance of photovoltaic systems on integration construction sites. In **Lebanon**, 25 young people are restoring heritage buildings while learning a trade.

Vocational training within companies: the corporate academy

The corporate academy aims to organise training directly with the company, sometimes even implementing it within the production facility. With the help of mentors, young people acquire skills that are precisely tailored to the needs of companies.

In **Lebanon**, for example, the IECD is developing integration programmes in maritime professions with the company CMA-CGM and in industry with Saltek.

Making a fresh start with your business

In many countries, entrepreneurship is both a means of personal fulfillment and a response to the lack of opportunities for paid employment. Supporting entrepreneurs is essential to reducing poverty and stimulating economic growth. However, this remains a challenge: according to the Global Entrepreneurship Monitor, nearly one in two aspiring entrepreneurs gave up on starting a business this year, a figure that has been rising since 2019.



Small informal businesses—crafts, trade, local services—are the largest source of employment and the main source of income for millions of people. Yet they remain precarious. Fear of failure or innovation hinders their development and limits their survival or growth.

In response to this situation, the IECED is rolling out entrepreneurship support programmes and concrete actions to strengthen the capacities of entrepreneurs. Businesses in the agri-food sector receive additional technical support to help them develop their manufacturing and packaging processes with a view to marketing innovative products that meet agri-food standards and market expectations.

Its systemic approach is based on three pillars:

1) Training and technical support for entrepreneurs

The IECED develops accessible training programmes tailored to each entrepreneur's profile, covering the launch, structuring, and sustainability of their business. These training courses include both technical and life skills development. Individualised support is also provided during the training and can continue for up to one year after graduation to provide answers and advice for the development of their business.

2) Developing entrepreneurial spirit

In an uncertain economic climate, the IECED promotes the life skills that are essential for entrepreneurial success, enabling entrepreneurs to get started, innovate, and overcome obstacles. These include specific programmes for women that include modules on leadership and empowerment, which are key levers for autonomy and transformation.

3) Building an ecosystem favouring the development of local businesses

To promote access to new business opportunities, the IECED strengthens synergies between local stakeholders. Particular attention is paid to women entrepreneurs, who are often less integrated into the "right" networks than their male counterparts, through targeted networking and partnerships with financial institutions tailored to their needs.

Supporting programmes to remove barriers to female entrepreneurship

In **Morocco**, following the devastating earthquake in September 2023, the IECD is supporting 140 women entrepreneurs in restarting their businesses and improving their living conditions.

The support includes measures to remove the peripheral barriers that women encounter in their entrepreneurial activities. For example, support for children's education is offered to compensate for the lack of time they must devote to their businesses, and psychosocial support is provided to boost their self-confidence and empowerment.

In several countries in **Central Africa** and **Egypt**, the IECD is rolling out support programmes for women entrepreneurs, enabling the women they work with to build their self-confidence and acquire the tools they need to develop their businesses.

Supporting the emergence of entrepreneurship with social and economic impact

The IECD is expanding its support services for businesses with high social and economic impact potential.

A pilot project in **Senegal** and **Cameroon** has helped businesses attract investors who can support them on their path to growth. In addition, in **Cameroon**, **Ivory Coast**, **Madagascar**, and the **Democratic Republic of the Congo**, the IECD supports companies receiving funding through personalised coaching aimed at ensuring sustainable and controlled growth.

Towards sustainable rural and agricultural entrepreneurship

The agricultural sector faces major challenges: feeding 9.7 billion people by 2050 (UN, 2022), adapting to climate change (+1.5°C by 2030 according to the IPCC), and limiting the degradation of agricultural land (52% already affected, FAO, 2021). Added to this is a growing disinterest among young people in a sector that still employs 27% of the global workforce (FAO, 2023).



In this context of transition, new models are emerging to produce, process, and consume differently. To build sustainable, attractive, and job-creating agriculture, the IECD is working alongside local stakeholders through three levers of intervention.

Developing the skills of entrepreneurs in the agricultural sector

The IECD designs and implements technical, commercial, and management training courses based on practical experience and a skills-based approach. More than 500 producers are being trained in agroecology in **Cameroon, Ivory Coast, Liberia**, and the **Central African Republic** through field schools. In the **Republic of the Congo**, a pilot programme has improved the practices of 200 fish farming professionals.

Testing and disseminating innovative solutions adapted to local areas

The IECD facilitates multi-stakeholder networks—farmers, advisors, businesses, researchers—to test, adjust, and disseminate relevant and sustainable agricultural practices. In **Lebanon**, a network of beekeepers is experimenting with new strategies to combat varroa mites, with concrete results. In **Liberia, Ivory Coast**, and **Cameroon**, trials conducted on 50 pilot plots have validated agroecological market gardening practices that are both profitable and adapted to local constraints.

Supporting entrepreneurial initiatives to develop and structure value chains

The IECD supports entrepreneurs and local organisations in developing essential services and innovative production models.

In the **Republic of the Congo**, fish feed manufacturers are testing formulations that improve the economic performance of fish farms, with **income increasing two to fivefold**. In **Cameroon**, **nearly 100 market gardeners** benefit from pre-financing and marketing services through a social enterprise, which helps to secure and improve their incomes.

My yields have doubled, and my sales have increased since I adopted more ecosystem-friendly practices.

Working alongside women to pave the way to employment and entrepreneurship

Nearly one in three women aged 15 to 24 worldwide is neither in employment, training, nor education—twice as many as men (ILO). However, at IECD, they represent nearly half of vocational training learners and 63% of entrepreneurs receiving support. The will is there. But there are still many obstacles: limited access to training, difficult integration into the job market, and glass ceilings for entrepreneurship. Behind the figures lie stories of struggle. And one thing is certain: supporting women means giving them the keys to empower themselves and move society forward.

The IECD makes the integration of women a key focus of its work. **It continuously tests, adjusts, and improves its solutions to provide women with long-term support on the path to independence.**

Training more women: a winning strategy

- Opening up opportunities: introducing young women to promising careers and the training programmes associated with them, so that they can access economic opportunities in their local areas.
- Facilitating access to training: boosting young women's self-confidence and convincing their families that they have a place in the workforce.

In **Central Africa**, the IECD is strengthening 12 vocational training centres to support more than **1,000 women** in their training, with a significant impact on enrollment in vocational programmes.

Thinking of learning spaces as drivers of inclusion and success

The IECD promotes training environments free of stereotypes, where every young person—girl or boy—can flourish. **It has therefore designed an e-learning programme for 315 training professionals.** This participatory course, based on real-life situations, strengthens their skills in inclusive teaching.

Removing barriers to integration and female entrepreneurship

- An internship or work-study programme is often the key to successful integration. The IECD forges partnerships with companies to accelerate the placement of young people in the workplace.
- Self-confidence and networking: two key factors for successful integration. Through initiatives specifically targeting women (women's career days, employability training, mentoring, Women's Entrepreneurs Club, etc.), the IECD and its partners give them more tools to succeed.
- In entrepreneurship, the IECD acts on the social and practical barriers that hinder initiative, management skills, or access to financing. In **Morocco**, in the region affected by the 2023 earthquake, **140 women**

are rebuilding their lives thanks to personalised entrepreneurial support, assistance with preschool education for their children, awareness-raising among families and husbands, networking, and material and financial support.

In **South-East Asia**, despite sustained economic growth, young people from vulnerable backgrounds remain largely excluded from the benefits of this boom. Lacking appropriate training, networks, or resources, they struggle to access skilled jobs.

To remove these barriers, the IECD is working with companies to provide training that offers prospects in the growing sectors of hospitality and catering, baking, and automotive maintenance.

At the same time, the IECD brings together and strengthens the capacities of hospitality training providers in the region and runs a "career accelerator" programme that has helped 1,580 young people find sustainable, high-quality jobs.

Finally, the IECD is developing several social integration enterprises. These offer young people a practical, high-quality and sustainable learning environment thanks to the financial resources generated.

Our work in sub-Saharan Africa and the Indian Ocean

With more than 60% of its population under the age of 25 (UN), **sub-Saharan Africa** is one of the youngest regions in the world. However, one in four young people is not in education or training (ILO). The economy remains largely informal, and opportunities for stable employment are limited, particularly for women and young people.

Faced with this reality, the IECD has adopted a regional approach focused on access to employment through training and entrepreneurship. Its structural projects aim to strengthen skills, encourage economic initiative, and provide access to sustainable jobs in promising sectors such as agroecology, fish farming, and solar energy.

In the **Mediterranean region**, despite its dynamism and energy, young people often experience high unemployment rates linked to economic growth that is lower than population growth, as well as the effects of climate change. In this context, in partnership with a strengthened network of 80 local associations, the IECD is implementing concrete solutions for 18,700 young people and entrepreneurs in vulnerable situations, particularly

young dropouts and victims of political crises or natural disasters.

Through training in job-creating sectors such as healthcare, industrial and electrical maintenance, baking, and maritime services, and through its "New Chance" programmes, the IECD promotes professional integration. It also works to create jobs and local prosperity by supporting the development of small businesses.

Our work in France



The IECD supports and strengthens the capacities of five high-impact social structures that help young people who are far from employment to get back on track, find guidance, receive training, and enter the workforce. They are located between Marseille and Paris: ACCES JOB, Appel d'Aire, Massajobs, L'Outil en Main, and Wake Up Café.

Supporting associations in their strategic development

Support is tailored to their specific needs. It can focus on strategic thinking for managers, organisational structuring, educational and training engineering, capitalisation, or development support.

Driving interactive dynamics

In line with the principle of "taking care of those who take care" and contributing to the continuous improvement support practices, the IECD brings together **more than 100 integration professionals from the Marseille ecosystem around:**

- thematic workshops and peer discussion groups for youth support workers,
- strategic support and individual coaching for managers of organisations to support them in their missions and strengthen collaborative dynamics,
- professional practice analysis sessions bringing together integration professionals.

Operating report

IECD's **operating budget** continues to grow to **€26.5 million** in 2024 and a stronger financial structure for the IECD enabling it to better prepare for the impact of the revision of ODA budgets.

► How do the financial results for 2024 reflect the transformations and strategic directions of the IECD?

This more moderate growth is part of a context marked by sharp declines in Official Development Assistance (ODA) which has impacted the IECD's activity since the last quarter of 2024. In response, **the IECD is refining its strategy,**

strengthening its tools and maintaining control of support function costs at less than 8% of the operating budget.

79 projects have been rolled out in the 18 countries where the IECD operates. New projects are being developed in long-standing countries such as **Madagascar, Lebanon, Ivory Coast** and **Liberia**. South-East Asia is confirming its potential with new activities in **Thailand** and the **Philippines**. In the Mediterranean basin, there is strong regional momentum, particularly in **Tunisia** and **Morocco**. For 2025, innovation and the search for new growth drivers are priorities across all of the IECD's areas of focus.

► How can financial discipline be combined with agility in a constantly evolving international environment?

In 2024, the IECD continued its strategy of diversifying funding sources while maintaining a strong commitment to both financial discipline and agility. The funding ratio remains dominated by public funds (58%) compared to private funds (42%), reflecting the development of major projects primarily financed by the French Development Agency and UN agencies. A rebalancing of the public-private ratio is now being considered.

Public funding enables the implementation of long-term, structuring programmes in the countries of operation. However, it is subject to increasingly stringent procedures, requiring greater methodological rigor from the teams and precise measurement of impact.

The IECD has strengthened its internal audit department and continued aligning its internal procedures with the growing demands for transparency, accountability, and compliance set by institutional funding partners.

Controlling support costs remains a priority, with efforts focused on striking the right balance in an increasingly complex regulatory environment, particularly in sub-Saharan Africa. The sharing of best practices among country offices and the anticipation of regulatory changes are also key elements of effective management. More than two-thirds of expenditures were successfully audited by independent firms, **confirming the robustness of the financial management.**

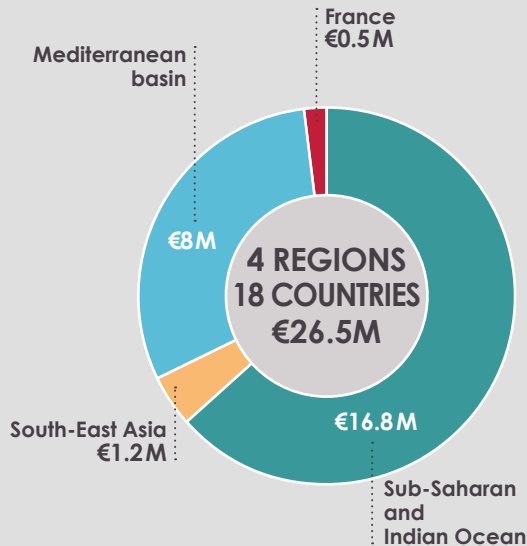
► What changes are you observing in the expectations of financial partners, and how is the IECD responding to strengthen its positioning?

The frequency of financial audits by key partners is driving us to adopt increasingly rigorous financial processes. We respond to this through the professionalisation and dedication of our teams, continuous improvement of our tools, and strong budgetary discipline in project implementation. **Our audit-rejected expenditure rate consistently remains below 0.1%.**

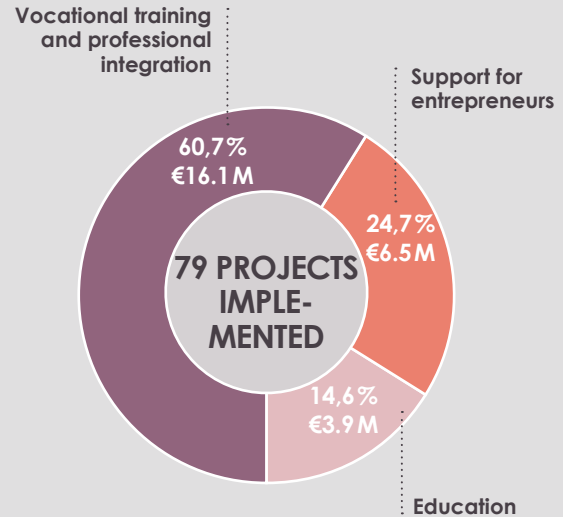
We have continued to invest in tools dedicated to AML-CFT compliance, screening, and **the training of both our direct teams and those of our local partners.**

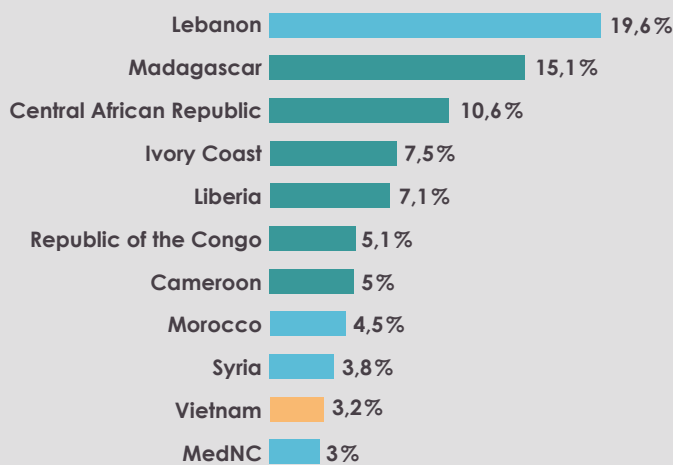
INVESTMENT BY REGION



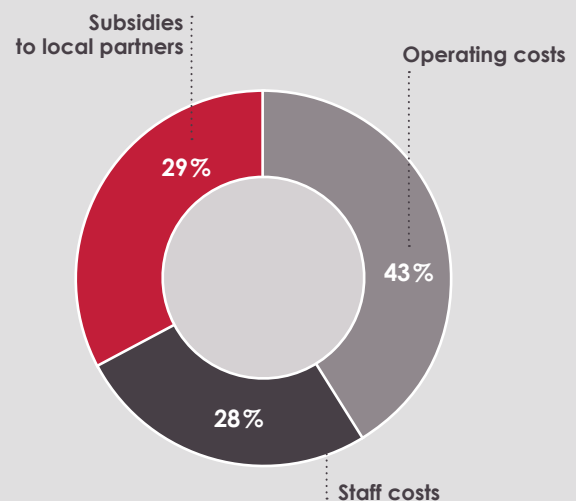
INVESTMENT BY SECTOR OF ACTIVITY



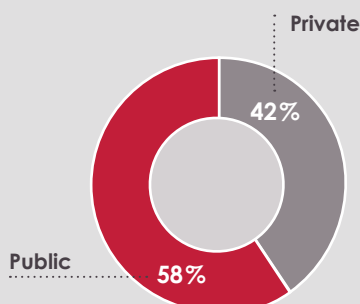
OPERATING BUDGET BY COUNTRY



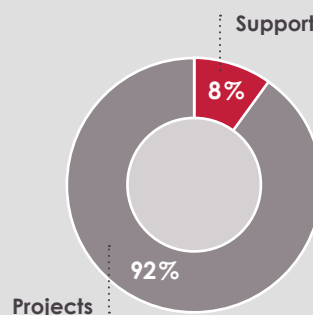
COSTS OF PROJECTS BY TYPE OF EXPENDITURE



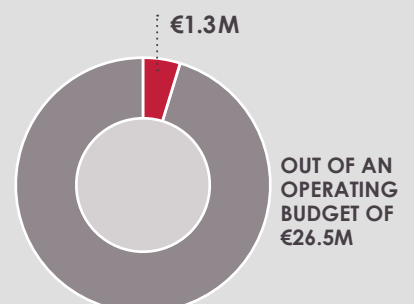
SOURCE OF FUNDING

Combined accounts

Combined accounts are the equivalent of consolidated accounts for a group of entities whose unity and cohesion derive from circumstances other than those provided for in article 357-1 of the French law of 24 July 1966 on commercial companies. The IECD thus combines the entities that contribute to its missions in the 18 countries of operation. These entities, governed by local law, are key partners forming the 'IECD Group'.

The following key entities are combined: **Semeurs d'avenir** in **Lebanon**, **PROMES** in **Madagascar**, **PEFACI** in the **Ivory Coast**, **IECD** in **Morocco**, the members of the **Enterprise Development Network**, **Les Boulangeries Françaises**, and **the social businesses**.

The combined expenses identified here take into account amounts directly committed by the combined entities, amounting to **€3.3 million in 2024**.
